Aberdour and Dalgety News

"IN THE RED."

We all know what that means. No one likes to be "in the red" or to have a deficit, or to run at a loss. When we are, it is a matter of great concern to us—to think that we are spending more than we have coming in.

You can imagine then the concern of the Congregational Board to discover that the congregation spent more last year than it had coming in, and that, not taking into account what was spent on St. Colme's Hall. We were short by £86. The concern of the Board is even greater because it knows that by 1966 our expenditure will increase by about £400. Unless something is done quickly our congregation is just not going to be able to meet her commitments, Those are: congregational expenses, the Coordinated Appeal, the Appropriate Stipend, the sum due to the Maintenance of the Ministry Committee for the poorer parishes, and the Aged and Infirmed Minister's Fund. All these are laid down for us by the General Assembly except the first, and we believe that our running of the Congregation is as economical as possible.

We are "in the red" and we are going to be more so, unless all our members look again at their givings, and decide to play their due part. Our givings increased last year by almost £100 but our expenditure by much more. We have many members who give generously but we have just as many who do not contribute more than a fraction of their share. In many cases this is thoughtlessness and will no doubt be put right.

If God has prospered you, and your income has increased since you last decided your yearly givings, have

you increased your offerings in proportion? What is a proper proportion to give for God's work in the world? 10%? 5%? 2%? 1%? Decide on your percentage and then work it out.

Pulpit Tribute - d. 4th February, 1964.

George Lambwas our Senior Elder. He had been an elder for forty three years. During that time he had witnessed many changes in Aberdour and in the Church. Those included the transition from worship in what is now the Church Hall to the restored St. Fillans in 1926 and the triple union of the three congregations in 1940. He had many interests, but with him the Church always came first. He was always thinking about it and living for it. He took his duties as elder very seriously, and for that reason he had a profound influence on the members in his district and those who lived around him. He had a special interest in each of the homes under his care and was quick to discover illness and need or 'the stranger that was within the gates.' Men in all walks of life respected him, and his influence was much wider than just within the fellowship of the Church. Men knew that his quiet and gentle way was the outcome of a deep and abiding faith. Men and women liked him and loved him and he was never known to say an unkind word about anyone.

He represented the Congregation in the Presbytery for many years until four years ago he was elected a 'parity elder' by Presbytery nomination. He will be greatly missed in the village and in the Church, as one who very humbly sought to follow his Master, Jesus Christ.

To-day we remember Mrs Lamb and the members of his family in their hour of parting.

"THANK YOU!" from KATHMANDU.

Dr P. J. Chandy, of the new leprosy hospital at Anandaban, Kathmandu, Nepal tells of a woman about 35 years of age, who was carried in a back basket for a distance of 15 miles by her mother, a woman of 60. The patient was highly lepromatous, had multipule ulcers, and, on the journey, developed pneumonia. With the patient were her two children, a boy of 12 and a girl of 14, both suffering from leprosy.

It is easy to imagine the miserable state of the quartet when they arrived at the already crowded hospital. Their condition was so desperate that Dr. Chandy asked three patients if they would give up their beds for the mother and her children so that they might have treatment without delay. They readily did so, enabling Dr. Chanday and his colleagues to save the mother's life. The

pneumonia has cleared up and all three have received treatment for their leprosy.

The £26 gathered by the Bible Class and the £9 given from the other Church organisations helped to make this possible. Thank you!
