Dear Friends,

Since the last issue of the magazine, two new names have appeared at the head of this page - Mrs. Karyn Crowe and Mrs. Catherine Duncan. It has been mentioned previously that Miss Carleen Simmers retired after 37 years as Clerk to the Congregational Board, but her successor has only recently been appointed - Mrs. Karyn Crowe. Karyn had secretarial experience before marriage and motherhood and was Secretary to the Aberdour School Board when it was functioning. I welcome her warmly to the post and am sure she will have the full support of the congregational Board in all her duties.

When I came to Aberdour in late 1975, the Session Clerk was Mr. Bill Chalmers. At the end of 1976 he resigned from that post, having served diligently and faithfully for twelve years, to be succeeded by Mr. Scott Stewart who had no sooner taken office than the Bank for which he worked moved him to another part of the country. The search for a successor was taken up again, and on 1st August 1977 Mr. Ian Foster took up the duties. At its meeting in April this year, the Kirk Session received a letter from Mr. Foster intimating his intention to retire at the end of June. Reluctantly the Kirk Session had to respect his wishes, for in these sixteen years he undertook all the duties required of him with diligence and cheerfulness, willingness and humility.

Session Clerk is an office in the Church that is peculiar to the Presbyterian Church, and the Church of Scotland in particular has been extremely fortunate in the very able men and women who have served in that capacity. Taking minutes of meetings,

dealing with correspondence, keeping the congregational roll, organising communion, preparing door duty rosters - these are just some of the duties undertaken by Ian during his years in office, and I personally am deeply grateful for the way in which he has carried them out. The Session Clerk is the minister's right hand "person", and when my left hand didn't know what it was doing, my right was always there to keep me on the The Kirk Session has appointed as his successor proper path. Mrs. Catherine Duncan who has been an active member of St. Fillan's for over 30 years and an elder for fourteen. She brings many gifts and talents to the office, and I am sure the Session's choice will be well justified in the future.

ing support for them.



SPONSORED GOLF COMPETITION

The Sponsored Golf Competition took place this year with the usual number of enthusiastic participants. Unfortunately the event got off to a bad start with no play possible on the Monday due to a water-logged course. However most of the players were accommodated on the other days with a most

The Aberdour team had a fairly comfortable lead at the start of the evening's play, but as the results came in Dalgety drew level and eventually took the lead to regain the David . Rutherford Trophy by 238 points to Aberdour's 235 points. The St. Fillan's Cup was won by Neil Hill with 42 points, and an amazing Scratch Score of 65 on the Thursday evening - equalled by Grahame Milne for Dalgety on Friday evening. The best lady was Jan Rough with 40 points.

Aberdour sponsors contributed £821.40, while Dalgety raised £1290.15, a very satisfactory total divided between Christian Aid and the Fife Macmillan Project. SOME THINGS NEVER CHANGE

Plus ca change, plus c'est la meme chose!
(The more things change, the more they are the same!)

I'm not trying to introduce a French lesson, but simply expressing some thoughts which came into my mind from two sources in recent weeks.

The first was on reading an article in the September issue of Life and Work under the heading "Questions for Today's Church", which dealt once more with the obligation for members to face up to their commitment in Christian Giving. Twenty years was the length of my service in the ordained ministry and it saddens me when I recall how much of that time seemed to be occupied in trying to deal with that particular matter. I shared our own minister's reluctance to raise the topic in the context of preaching, but in a charge which struggled to pay the Minimum Stipend it was almost impossible to avoid the issue as it arose with distressing frequency whenever finance raised its ugly head. Wherever the fault lay and whoever was responsible, I hesitate to give an answer, but certainly my experience was - "the more thing change, the more they are the same!"

The other occasion which made me think about this was on seeing the programme presented on the B.B.C. "Everyman" series the other week, which dealt with the Anglican Service of "Evensong". Even with the background of a Presbyterian tradition, there must be few who cannot appreciate, and at times be moved by, the haunting words and music which comprise this act of worship, especially when heard in the setting of a large cathedral. A lady described very movingly the influence which she had found over many years from sharing in the service and, living in Winchester, she was still actively involved in the work of the Diocese. All this was part of a tradition which had continued over many centuries, but she also saw it as worship which was "acceptable and well pleasing to God" because it seemed to convey an eternal dimension to her living which obviously gave her much satisfaction.

It would seem that this particular cathedral is fortunate in having a choir of many young people and a Choirmaster who is looking for ways in which the service can adapt to our changing circumstances without losing its essential character. But I'm sure that finance will always be a constant concern in that situation with the recurring question of "how much longer shall

we be able to cover the cost of it all?"

Once there were committed people in every denomination who were in the fortunate position that they could provide the means which would prevent such problems arising. Nowadays the commitment has got to be shared among a much larger section of society than just the lairds and landed gentry.

But how many are prepared to accept this challenge and believe that what is offered is "acceptable and well pleasing to God"? The answer to that question may well decide whether or not we can finally dispense with the saying: Plus ca change, plus c'est la meme chose!
